6 INVESTMENT

7
8 SCOPE, COVERAGE AND DURATION
9

10 1. This Chapter shall apply to measures¹ affecting:

- 11
12 a) investments (of investors of a Party) in the territory of another party existing at the
13 time of entry into force as well as to investments made or acquired thereafter; and
14
15 b) investors of a Party in the establishment, acquisition, expansion, management,
16 conduct, operation and sale or other disposition of investments in the territory of
17 another Party.
18
19 c) all investments in the territory of any Party as provided in Article ____
20 (performance requirements).
21

22 2. USA[With respect to investments established prior to the date of termination of this
23 Agreement and to which this Chapter otherwise applies, the provisions of all of this Chapter
24 shall thereafter continue to be effective for a further period of ten
25 years from such date of termination.]
26

27 3. This Chapter shall not apply to:

28
29 MEX[a) any measure taken pursuant to a restriction expressly mandated by the
30 Constitution of a Party.]²
31

32 b) the provision of financial services or insurance CDA[except as provided in the
33 Chapter on Financial Services;]
34

35 **U.S. Note 1 - While financial services will be covered in the financial services**
36 **chapter, certain provisions of the investment chapter may apply to financial**
37 **services by cross-reference in the financial services chapter.**
38

39 c) government procurement CDA[except as provided in the Chapter on Government
40 Procurement;] USA[of goods and services supplied by investments in its territory
41 controlled by nationals of a non-Party and procurement by states, provinces or
42 political subdivisions of a Party];
43

44 d) MEX CDA[services listed in Annex Y01.3(c)]

- 1 e) CDA[public or private entities in respect of their activities forming part of a
2 statutory system of social security, health care, education, day care, or public
3 retirement plans;]³
4
5 f) CDA[subject to Article 106 (Nullification or Impairment of Benefits), any subsidy.]
6
7 g) CDA[as between Canada, the United States of America, and the United States of
8 Mexico, cultural industries as defined in article 2012 of the U.S.-Canada Free
9 Trade Agreement.]⁴
10
11 4. MEX USA[Each Party reserves the right to deny to an entity of another Party the
12 advantages of this Chapter if:
13
14 a) nationals of any non Party own or control such entity and such entity has no
15 substantial business activities in the territory of the Party under whose laws it is
16 constituted;] USA[or
17
18 b) such entity is owned or controlled by nationals of a non-Party with which the
19 denying Party does not maintain normal economic relations.] MEX[such entity is
20 owned or controlled by nationals of a non-Party from which the denying Party
21 prohibits all investment.]⁵
22

23 ENVIRONMENTAL MEASURES⁶

- 24
25 1. The Parties affirm that this Chapter shall not be construed to prevent the adoption or
26 enforcement of any measure, otherwise consistent with this Chapter, that a Party deems
27 appropriate to ensure that investment activity in its territory is undertaken in a manner sensitive
28 to environmental concerns.
29
30 2. No Party shall, as an inducement or incentive to the establishment, acquisition, or
31 expansion of an investment of an investor of another Party, eliminate, waive, reduce, or
32 otherwise derogate from measures of general application necessary to protect human, animal or
33 plant life or health or the environment in its territory, or from measures relating to the
34 conservation of exhaustible natural resources.

4 ADDITIONAL CANADIAN EQUIVALENCES

From Canadian Protocol, Part 2: SPECIFIC COMMITMENTS AND EXCEPTIONS

5. Notwithstanding any provision of the Agreement, Article 2005 of the Canadian-United States Trade Agreement shall continue to apply as between Canada and the United States.

TREATMENT OF INVESTMENTS

1. National Treatment

- a) Each Party shall accord to investments of investors of another Party USA MEX[, and activities associated therewith,] treatment no less favourable than that which it accords, in like circumstances, to investments of its own investors.
- b) Each Party shall accord to an investor of another Party treatment no less favourable than that which it accords, in like circumstances, to its own investors in respect of the establishment, acquisition, expansion, management⁷, conduct, operation and sale or other disposition of investments in its territory.
- c) For greater certainty, no Party shall
 - i) impose on an investor of another Party a requirement that a minimum level of equity in a business enterprise in its territory be held by its nationals, other than nominal qualifying shares for directors or incorporators of corporations; or
 - ii) require an investor of another Party, by reason of its nationality, to sell or otherwise dispose of an investment in its territory.

2. MFN Treatment

- a) Each Party shall accord to investments of an investor of another Party USA MEX[, and activities associated therewith,] treatment no less favourable than that which it accords, in like circumstances, to the investments of an investor of any other Party or of a non-Party.
- b) Each Party shall accord to an investor of another Party treatment no less favourable than that which it accords, in like circumstances, to investors of any other Party or non-Party in respect of its establishment, acquisition, expansion, conduct, management⁷, operation and sale or other disposition of its investment in its territory.

3. Non-Discriminatory Treatment

The treatment that a Party shall accord to investments USA MEX[and associated activities] of another Party and to investors of that Party shall be the better of the treatment required by paragraphs 1(a), (b), and (c) and 2 (a) and (b). ("Nondiscriminatory treatment")]

4. Minimum Standard of Treatment

Each Party shall accord at all times to the investments in its territory of investors of another Party full protection and security, fair and equitable treatment, and in all other respects as well, treatment in accordance with international law.

1 5. Without prejudice to paragraph 3, investors of a Party whose investments suffer losses
2 in the territory of another Party owing to conflict or civil strife shall be accorded at least
3 nondiscriminatory treatment by such other Party as regards any measures it adopts in relation
4 to such losses.

5
6 6. MEX USA[A Party shall not require that entities which are legally constituted under the
7 applicable laws or regulations of one Party, and which are investments of investors of another
8 Party, engage as top managerial personnel individuals of any particular nationality.]
9

10 7. The most favored nation obligations of this Chapter shall not apply to advantages
11 accorded by a Party by virtue of the Party's binding obligations under any multilateral
12 international agreement under the framework of the General Agreement on Tariffs and Trade
13 and other matters as set forth in Annex ____.

14
15 8. a) The obligations of paragraphs 1, 2, 3 and 6 shall not apply to :

16
17 i) a non-conforming provision of any existing measure⁸ which is maintained by
18 a Party at the federal level, and which that Party, as of the date of the
19 signature of this Agreement, has described in Annex A;

20
21 ii) a non-conforming provision of any existing measure which is maintained by
22 a state or province of a Party, and which that Party described in Annex A
23 within two years after the entry into force of this Agreement; or

24
25 iii) a non-conforming provision of any existing measure which is maintained by
26 a local government of a Party.

27
28 b) A party may promptly renew such a non-conforming provision of any existing
29 measure, or amend such a non-conforming provision of any existing measure, to
30 the extent that the renewal or amendment does not decrease its conformity with the
31 obligations of this Chapter.

32
33 c) The obligations of paragraphs 1, 2, 3 and 6 shall nonetheless apply to the extent to
34 which a Party has undertaken in Annex A to bring such non-conforming measures
35 in closer conformity with those obligations during the term of this Agreement.

36
37 d) As a further departure from the obligations of paragraphs 1 and 2, which should
38 occur only in the most limited circumstances, a Party, by the date of signature of
39 this Agreement, may identify in Annex B activities or sectors in respect of which it
40 maintains non-conforming provisions of existing measures and in respect of which
41 it shall be permitted to impose non-conforming measures in the future.

42
43 9. MEX USA[Where a Party has or takes a measure covered in Annexes A and B it shall
44 nonetheless accord most favored nation treatment unless set forth in the respective annex.]
45

46 10. Nothing in this Chapter shall preclude a Party from prescribing special formalities in
47 connection with the making of investments by nationals or companies of another Party,

1 provided such formalities do not impair the substance of any of the rights set forth in this
2 Chapter.

3
4 11. CDA[Where a Party requires a service provider of another Party to provide a bond or
5 other form of financial security before providing a service into its territory, the provisions of
6 that service shall be subject to the provisions of Chapter ____ (Cross-Border Trade in
7 Services) except as regards the Party's treatment of the required bond or financial security.]

8
9 12. CDA[The Parties shall implement the provisions of Annex ____ regarding measures
10 affecting investors of the other Parties.]

11
12 13. USA[a] As a further exception to [provision on national treatment]⁹, and only in respect
13 of sectors reserved for the state on the date of entry into force of this Agreement,

14
15 (i) a Party, when privatizing an enterprise owned by it in such a sector, may sell
16 all or a portion of its equity interests to its nationals; and

17
18 (ii) a Party, when permitting private investment in such a sector, may require that
19 a specified level of equity in business enterprises in that sector be held by its
20 nationals.

21
22 b) For state enterprises not in sectors reserved to the state at the date of entry into
23 force of this Agreement, but carrying on an activity on the date of entry into force
24 of this Agreement, a Party may limit the initial acquisition of its interests in the
25 enterprise to its nationals. However, once the Party's interests have been sold, the
26 obligations of paragraph 1 (national treatment) shall apply.¹⁰

27
28 MEX USA[14. The treatment accorded by a Party under paragraphs 1, 2 and 3 with respect to
29 nationals and entities of another Party shall, in any state or political subdivision¹¹, be no less
30 favorable than the treatment accorded by such state or political subdivision¹¹ to its residents,
31 or entities legally constituted under its laws, or their investments in its territory.]

32
33 CDA[14. The provisions of this Article shall mean, with respect to measures of a
34 province or state, treatment no less favorable than the most favorable treatment accorded by
35 such province or state to investors, in like circumstances, of the Party of which it forms a
36 part.]

37
38 14. Notwithstanding paragraphs 1, 2 and 3 a Party may require routine information, to be
39 used solely for informational or statistical purposes, concerning an investment of an investor of
40 another Party in its territory. Such Party shall protect such business information that is
41 confidential from disclosure that would prejudice the investor's competitive position.

- 2 15. Nothing in paragraph 14 shall preclude a Party from otherwise obtaining or disclosing
- 3 information in connection with the equitable and good faith application of its laws.

PERFORMANCE REQUIREMENTS

1. CDA[[Except as provided in Annex ____)], no Party shall apply USA[or enforce], in connection with the establishment, acquisition, expansion, conduct or operation of an investment in its territory of an investor of a Party or MEX[non-Party], any of the following requirements CDA[enforceable under domestic law or administrative ruling]:

- a) to export a given level or percentage of goods or services;
- b) to achieve a given level or percentage of domestic content;
- c) CDA[substitute goods or services from the territory of such Party for imported goods or services;]
- d) to purchase or use goods or services of domestic origin or from domestic producers or service providers, or otherwise accord a preference to goods or services produced in such territory;
- e) to relate in any way the volume or value of exports or to the amount of foreign exchange inflows associated with such investment;
- f) to restrict domestic sales of goods or services that such investment produces by relating such sales in any way to the volume or value of its exports or foreign exchange earnings;
- g) USA MEX[transfer a particular technology, production process or other proprietary knowledge to a national or entity in its territory, except:
 - i) when imposed by a court or administrative tribunal to remedy an alleged violation of competition laws; or
 - ii) where necessary or appropriate to protect health, safety or the environment;]
- h) USA MEX[act as the exclusive supplier of the goods or services it produces to a specific, or world market or region.]

2. CDA MEX[[Except as provided in Annex ____)], no Party shall condition the receipt or continued receipt of an incentive, in connection with investments in its territory of investors of a Party or non-Party, on any of the following requirements CDA[enforceable under domestic law or administrative ruling]:

- a) CDA[export a given level or percentage of goods;]
- b) USA MEX[prescribe in any way the purchase or use of goods of domestic origin or from domestic producers;]
- b) CDA[purchase or use goods of domestic origin or from domestic producers, or otherwise accord a preference to goods produced in such territory;]
- c) achieve a given level or percentage of domestic content;

- 1 d) CDA[substitute goods from the territory of such Party for imported goods;]
2
3 e) relate in any way the volume or value of imports to the volume or value of exports
4 or to the amount of foreign exchange inflows associated with such investment;
5
6 f) restrict domestic sales of goods or services that such investment produces by
7 limiting such sales in any way to the volume or value of its exports or foreign
8 exchange earnings;
9
10 g) USA MEX[to act as the exclusive supplier of the goods or services it produces to a
11 specific, or world market, or region.]
12

13 3. USA MEX[Notwithstanding paragraph 2, a Party may nonetheless condition the receipt of
14 an incentive on commitments to locate production or employ workers in its territory, construct
15 or expand particular facilities, or to spend the incentive in its territory.]
16

17 4. The provisions of CDA[this Article] USA MEX[paragraphs 2(b) and 2(c)] shall not apply
18 to:
19

- 20 a) USA MEX[eligibility criteria for purposes of government procurement or export
21 promotion programs;]
22
23 b) CDA[measures related to government procurement;]
24
25 c) CDA[the provision of subsidies consistent with Article XVI of the GATT and the
26 Agreement on the Interpretation and Application of Article VI, XVI and XXIII of
27 the GATT, including any amendments, modifications or successor agreements
28 thereto;]
29

30 5. CDA MEX[No Party shall prohibit or otherwise restrict an investor established in the
31 territory of another Party from:
32

- 33 a) exporting goods and services originating from such territory to a non-party
34 country, unless pursuant to a measure of general application consistent with Article
35 ___ (on export restrictions);
36
37 b) importing to such territory goods and services originating from a non-party; or
38
39 c) using goods and service originating in a non-party country.
40

41 6. MEX CDA[Nothing in this Chapter including the principle of non-discrimination shall
42 prevent a Party from imposing requirements on an investor of a Party or non-Party in respect
43 of activities not listed in paragraphs 1 or 2.]

1 TRANSFERS

2
3 1. Subject to paragraph 3 MEX CDA[and paragraphs 5 and 6] a Party shall permit all
4 transfers and international payments (hereinafter "transfers") relating to an investment in its
5 territory of an investor of another Party to be made freely and without delay. Such transfers
6 include:

- 7
8 a) profits, dividends, interest, capital gains, royalty payments, management, technical
9 assistance and other fees, returns in kind, and other amounts derived from an
10 investment;
11
12 b) proceeds from the sale of all or any part of an investment or from the partial or
13 complete liquidation of an investment;
14
15 c) payments made under a contract entered into by an investor, or investment,
16 including payments made pursuant to a loan agreement;
17
18 d) compensation pursuant to {Article on expropriation}; and
19
20 e) payments arising out of an investment dispute MEX USA[as defined in {Article on
21 dispute settlement}.]
22

23 2. MEX USA[Except as provided in paragraph 2 of {Article on expropriation} and] subject to
24 paragraph 3, a Party shall permit transfers to be made in a freely usable currency at the market
25 rate of exchange prevailing on the date of transfer with respect to spot transactions in the
26 currency to be transferred.
27

28 3. A Party may, through the equitable and good faith application of its laws, prevent any
29 transfer referred to in paragraph 1 if such transfer is inconsistent with any measure of general
30 application relating to:

- 31
32 a) CDA[restrictions applied by a Party to persons of another Party on the making of
33 payments and transfers for current international transactions which conform with
34 Article VIII of the Articles of Agreement of the International Monetary Fund;]
35
36 b) bankruptcy, insolvency or the protection of the rights of creditors;
37
38 c) issuing, trading or dealing in securities;
39
40 d) criminal or penal offenses;
41
42 e) reports of currency transfers;
43
44 f) imposing taxes by such means as a withholding tax; or
45
46 g) ensuring the satisfaction of judgments in adjudicatory proceedings.
47

1 4. Notwithstanding paragraphs 1, 2, and 3 of this Article, a Party may maintain or adopt
2 restrictions on the transfer of "returns in kind" (goods and services) that are otherwise in
3 conformity with the provisions of this Agreement.¹²
4

5 5. MEX CDA[No Party shall require its investors to repatriate, or penalize its investors who
6 fail to repatriate, the income, earnings or profits attributable to any investment in another
7 Party or to any businesses carried on in another Party either directly by the investors or
8 indirectly through a business enterprise established in that other Party.]
9

10 6. MEX CDA[Paragraph 4 shall not be construed as preventing a Party from taxing its
11 investors on their share of any income, earnings or profits attributable to a business carried on
12 or an investment made in another Party, provided that the tax so charged does not exceed the
13 tax that would be so charged if such income, earnings or profits were repatriated, without any
14 further tax on the repatriation, to its investors.]

1 STATE ENTERPRISES

2
3 CDA[DRAFT DISCUSSION PAPER
4

5 1. Nothing in this Agreement shall prevent a Party from maintaining or establishing a
6 state enterprise.
7

8 2. The Party maintaining or establishing a state enterprise shall ensure, whether regulatory
9 supervision, administrative control or the application of other measures, including where
10 appropriate, through the application of its domestic competition laws, that the state enterprise:

11
12 a) in the provision of its goods or services in the territory of the Party, accord
13 nondiscriminatory treatment to investments of investors of another Party;
14

15 b) where engaged in non-regulated commercial activities in competition, in the
16 relevant market within the territory of such Party or any part thereof, with
17 investments of investors of another Party, does not engage in anti-competitive
18 practices that adversely affect investments of investors of another Party.
19

20 3. Where a state enterprise of a Party is engages in competition with investments of
21 investors of another Party in the relevant market within the territory of that Party or any Part
22 thereof, that Party shall accord to investments of investors of the other Party, treatment no less
23 favorable than that accorded, in like circumstances, to investors of any other private persons.]
24

25 USA[1.The provisions of this Chapter, and in particular the obligation to accord
26 nondiscriminatory treatment to investments in the territory of a Party of investors of another
27 Party, shall apply to the state enterprises of a Party.
28

29 2. Further to Article (concerning nondiscriminatory treatment), where a state enterprise of
30 a Party is in competition, within the territory of such Party, with an investment of an investor
31 of another Party, and where there are no other investments of investors of that Party which are
32 not state enterprises in competition with the state enterprise, that Party shall accord the
33 investment of the investor of the other Party treatment no less favorable than that which it
34 provides its state enterprise. Where investments of investors of that Party which are not state
35 enterprises also compete with the state enterprise, the investment of the investor of the other
36 Party shall be accorded treatment no less favorable than that provided such other investments.]

1 EXPROPRIATION AND COMPENSATION

2
3 1. No Party shall directly or indirectly nationalize or expropriate an investment of an
4 investor of another Party in its territory or take any measure or series of measures tantamount
5 to expropriation or nationalization of such an investment ("expropriation"), except:

- 6
7 a) for a public purpose;
8
9 b) on a nondiscriminatory basis;
10
11 c) in accordance with due process of law and the general principles of treatment
12 provided in paragraph 3 Article (on treatment of investment); and
13
14 d) upon payment of compensation in accordance with paragraph 2.
15

16 2. Compensation shall be equivalent to the fair market value of the expropriated
17 investment immediately before the expropriatory action was taken or became known,
18 whichever is earlier. Valuation criteria shall include going concern value, asset value
19 (including declared tax value of tangible property), and other criteria, as appropriate to
20 determine fair market value. Compensation shall be paid without delay; be fully realizable;
21 and be freely transferable USA CDA[into a currency of a country which is a member of the
22 Group of Seven]. The amount paid shall be no less when converted into a currency of a
23 MEX[Party] USA CDA[country which is a member of the Group of Seven], than if compensation
24 had been paid on the date of the expropriation, had been converted into that currency at the
25 market rate of exchange prevailing on the date of valuation, and had earned interest at a
26 commercially reasonable rate for that currency until the date of payment.]

1 **DISPUTE SETTLEMENT**

2
3 USA[1. The provisions of this article reflect the desirability of a mechanism for the settlement
4 of investment disputes that assures equal treatment between investors of the Parties in
5 accordance with the principle of international reciprocity and that assures that the Parties to the
6 dispute are afforded due process before an impartial tribunal.

7
8 2. For purposes of this Article, an investment dispute means a dispute between a Party
9 and an investor of another Party involving an alleged breach of any right conferred by this
10 Chapter. An investment dispute shall not include an alleged breach of this Chapter where the
11 very measure constituting the alleged breach is itself expressly permitted by another Chapter.

12
13 3. In the event of an investment dispute, the parties to the dispute should initially seek a
14 resolution through consultation and negotiation. If the dispute cannot be settled amicably, the
15 investor concerned may choose to submit the dispute for resolution:

- 16
17 a) to the courts or administrative tribunals of the Party that is a Party to the dispute;
18 or
19
20 b) in accordance with the terms of paragraph 4.

21
22 The choice made by the investor shall be exclusive. If the investor chooses to submit the
23 dispute for resolution in accordance with paragraph 4, the investor may seek as final relief
24 only monetary damages or restitution of property.

25
26 4. Provided that the investor concerned has not submitted the dispute for resolution under
27 paragraph 3 (a) and that six months have elapsed from the date on which the dispute arose, the
28 investor concerned may submit the dispute for settlement by binding arbitration:

- 29
30 a) to the International Centre for the Settlement of Investment Disputes ("Centre")
31 established by the Convention on the Settlement of Investment Disputes between
32 States and Nationals of other States, done at Washington, March 18, 1965 ("ICSID
33 Convention"), provided that the Party concerned is a party to such Convention;
34
35 b) to the Additional Facility of the Centre, if the Centre is not available; or
36
37 c) in accordance with arbitration Rules of the United Nations Commission on
38 International Trade Law (UNCITRAL).

39
40 5. Notwithstanding paragraphs 3 and 4, the investor and the Party to the dispute may
41 mutually agree to arbitration in accordance with other arbitration rules or before another
42 arbitration institution.

43
44 6. Each Party hereby consents to the submission of any investment dispute for settlement
45 by binding arbitration in accordance with the choice made by the investor under paragraph 4.
46 Such consent, together with this submission of the dispute by the investor under paragraph 4 or
47 5 shall satisfy the requirement for:

- 48
49 a) written consent of the parties to the dispute for purposes of Chapter II of the ICSID
50 Convention (Jurisdiction of the Centre) and for purposes of the Additional Facility
51 Rules;

- 1 b) an "agreement in writing" for purposes of Article II of the United Nations
2 Convention of the Recognition and Enforcement of Foreign Arbitral Awards, done
3 at New York, June 10, 1958 ("New York Convention"); and
4
5 c) an "agreement" for purposes of Article I of the Inter-American Convention on
6 International Commercial Arbitration ("Inter-American Convention".)
7

8 Any such investment dispute shall be considered to arise out of a commercial
9 relationship or transaction for purposes of Article I of the New York Convention and Article I
10 of the Inter-American Convention.
11

12 7. Unless the parties to an investment dispute agree otherwise the place of any arbitration
13 under paragraphs 4 or 5 of this Article shall be in the territory of a Party to this Agreement
14 that is a party to the New York Convention, such place to be selected in accordance with the
15 applicable arbitration rules.
16

17 8. The arbitral tribunal constituted pursuant to paragraph 4 or 5 shall decide the dispute in
18 accordance with the provisions of this Agreement and applicable rules of international law.
19

20 9. [Subject to the applicable provisions of the New York Convention, the Inter-American
21 Convention, and the ICSID Convention],
22

- 23 a) any arbitral award resulting from an arbitration under paragraphs 4 or 5 of this
24 Article shall be final and binding on the parties to the dispute; and
25
26 b) each Party undertakes to carry out without delay the provisions of any such award
27 and to provide for its enforcement.
28

29 10. In an arbitration held pursuant to paragraphs 4 or 5, the Tribunal may determine any
30 incidental or additional claims or counterclaims arising directly out of the acts or measures
31 constituting the alleged breach of this Chapter, except as the parties to the investment dispute
32 otherwise agree. In any proceeding involving an investment dispute, a Party shall not assert, as
33 a defense, counterclaim, right of set off or otherwise, that the investor concerned has received
34 or will receive, pursuant to an insurance or guarantee contract, indemnification or other
35 compensation for all or part of its alleged damages.
36

37 11. For purposes of an arbitration held under paragraph 4 or 5 of this Article, any company
38 legally constituted under the applicable laws and regulations of a Party or a political
39 subdivision thereof but that, immediately before the occurrence of the event or events giving
40 rise to the dispute, was an investment of nationals or companies of another Party, shall be
41 treated as an investor of such other Party, including in accordance with Article 25(2)(b) of the
42 ICSID Convention.
43

44 12. No Party shall give diplomatic protection, or bring an international claim for money
45 damages or restitution of property, in respect of the investment dispute which one of its
46 investors shall have submitted to arbitration under this Article, unless such other Party shall
47 have failed to abide by and comply with the award pursuant to the New York Convention.
48 Diplomatic protection, for purposes of this paragraph shall not include state-to-state dispute
49 settlement pursuant to Article ____ of this Agreement, or informal diplomatic exchanges for the
50 sole purposes of facilitating settlement of a dispute.
51

1 Provision for the Investment Chapter that might be taken into the General provisions:

2
3 A Party shall have a defense to a claim under Article ____ to the extent that the very measure
4 constituting the alleged breach of this Chapter is itself expressly authorized by another
5 Chapter.]

7 USA[SETTLEMENT OF DISPUTES BETWEEN PARTIES
8

9 1. Any dispute between Parties concerning the interpretation or application of this Chapter
10 which is not resolved through consultations or other diplomatic channels, shall be submitted,
11 upon the request of a Party, for binding decision in accordance with the applicable rules of
12 international law to an arbitral tribunal composed of three arbitrators.

14 2. In the absence of an agreement by the Parties to the contrary, the arbitration rules of
15 the United Nations Commission on International Trade Law (UNCITRAL) shall apply. The
16 appointing authority referenced in those rules shall be the Secretary General of the Centre.

18 3. Fees and expenses of the arbitrators and appointing authority, and other costs of the
19 proceedings, shall be borne equally by the Parties. Each Party shall bear the cost of its legal
20 representation.]

22 CDA[ARTICLE XX07: SETTLEMENT OF DISPUTES BETWEEN A PARTY AND AN
23 INVESTOR OF ANOTHER PARTY.
24

25 1. The provisions of this Article reflect the desirability of a mechanism for the settlement
26 of investment disputes that assures equal treatment between investors of the Parties to this
27 Agreement in accordance with the principle of international reciprocity and that assures that
28 the parties to the dispute are afforded due process before an impartial tribunal.

30 2. Definitions

31
32 For purposes of this Article,

- 33
34 (a) "disputing parties", in relation to an investment dispute, means the investor and the
35 disputing Party;
36
37 (b) "disputing Party", in relation to an investment dispute, means the Party to this
38 Agreement alleged to have breached a right conferred by this Chapter;
39
40 (c) "ICSID Convention" means the Convention on the Settlement of Investment
41 Disputes between States and Nationals of other States, done at Washington, March
42 18, 1965;
43
44 (d) "Inter-American Convention" means the Inter-American Convention on
45 International Commercial Arbitration, done at Panama, [Month] [Day], 1975;
46
47 (e) "investment dispute" means a dispute between a Party to this Agreement and an
48 investor of another Party whereby the investor alleges that the first-mentioned
49 Party has breached a right conferred by this Chapter and that it has suffered loss or
50 damage by reason of, or arising out of, that breach, but does not include a dispute
51 with respect to

- (i) measures that are inconsistent with this Chapter but that are authorized by other provisions of this Agreement,
 - (ii) non-conforming provisions of measures covered by Articles ... and Annexes ... ; or
 - (iii) an alleged breach of any right to the security of the person of an investor;
 - (f) "New York Convention" means the United Nations Convention on the Recognition and Enforcement of Foreign Arbitral Awards, done at New York, June 10, 1958;
 - (g) "UNCITRAL" means the United Nations Commission on International Trade Law.
3. Negotiation
- In the event of an investment dispute, the disputing parties should attempt first to settle the dispute by consultation and negotiation.
4. Arbitration
- (1) If an investment dispute cannot be settled by consultation and negotiation, the investor may, subject to subparagraphs (2) to (4), submit the dispute for settlement by arbitration:
 - (a) to the International Centre for the Settlement of Investment Disputes ("Centre") established by the ICSID Convention, provided that the disputing Party and the Party of the Investor are parties to that Convention;
 - (b) to the Additional Facility of the Centre, if the disputing Party is not a Party to the ICSID Convention; or
 - (c) in accordance with the UNCITRAL Arbitration Rules.
 - (2) The investor may submit the investment dispute to arbitration under subparagraph (1) on condition that the investor
 - (a) waive his rights to initiate or continue before any court or administrative tribunal of the disputing Party any proceedings in respect of a breach of the domestic law of that Party and in which the matter at issue is substantially the same as the matter at issue in the arbitration proceeding;
 - (b) waive execution under the New York Convention of any arbitral award made in an arbitration proceeding initiated under subparagraph (1), except in a country that is both a Party to the New York Convention and a Party to this Agreement; and
 - (c) agrees that the defending Party can establish an arbitral panel under paragraph 8 or 9.

1 (3) An investor who intends to submit an investment dispute to arbitration under
2 subparagraph (1) shall give notice of his intention to the disputing Party at least ninety days
3 before that proceeding is initiated, which notice shall
4

5 (a) designate precisely the parties to the dispute and state the address of each;
6

7 (b) set forth the provisions of this Agreement alleged to have been breached and any
8 other relevant provisions; and
9

10 (c) contain information concerning the issues in dispute and an indication of the
11 amount involved.
12

13 (4) An investor is not entitled to initiate arbitration under subparagraph (1) if
14

15 (a) less than six months have elapsed since the date on which the investment dispute
16 arose;
17

18 (b) more than two years have elapsed since the date on which the investor first
19 acquired, or should have first acquired, knowledge of the alleged breach that is at
20 issue in the dispute; or
21

22 (c) the disputing Party has requested the establishment of an arbitral panel in
23 accordance with paragraph 8 or 9.
24

25 (5) An arbitration proceeding under subparagraph (1) is initiated on the date, as
26 applicable, on which
27

28 (a) the notice of registration of the request to institute arbitration proceedings has been
29 dispatched by the Secretary-General of the Centre in accordance with paragraph (3)
30 of Article 36 of the ICSID Convention;
31

32 (b) the certificate of registration of the notice for arbitration has been dispatched by the
33 Secretary-General of the Centre in accordance with of Article 4 of Schedule C of
34 the Additional Facility Rules; or
35

36 (c) the notice of arbitration given under the UNCITRAL Arbitration Rules is
37 received by the disputing Party.
38

39 5. (1) An investor of a Party shall not have a right of action under the domestic law of
40 another Party for any breach of this Agreement by that other Party.
41

42 (2) If an arbitration proceeding is initiated in respect of an investment dispute, the
43 investor shall cease to have any right to initiate before any court or administrative tribunal of
44 the disputing Party any proceedings in respect of a breach of the domestic law of that Party in
45 which the matter at issue is substantially the same as the matter at issue in the arbitration
46 proceeding.
47

48 6. An arbitral tribunal to which an investment dispute is referred for arbitration in
49 accordance with paragraph 4 may decline to address an issue, reserve its decision on an issue,
50 or stay the proceedings before the tribunal, pending decision by any other arbitral tribunal or
51 panel on the same issue.

2 7. A disputing Party may, within ninety days after service of
3 a notice under subparagraph 4(3) in respect of the investment dispute,
4

5 (a) request the establishment of an arbitral panel in accordance with paragraph 8, if it
6 considers that any actual or proposed measure or other matter that is at issue in the
7 dispute, or at issue in the dispute and in other investment disputes in which it is a
8 disputing Party, might significantly affect the operation of this Agreement; or

10 (b) request the establishment of an arbitral panel in accordance with paragraph 9, if it
11 considers that the dispute, or the dispute and other investment disputes in which it
12 is a disputing Party, raises important issues of public policy or that the dispute and
13 other investment disputes in which it is a disputing Party should be consolidated.

15 8. (1) A disputing Party may request the [North American] Trade Commission to
16 establish an arbitral panel in accordance with Article 2309.
17

18 (2) The request shall state the measure or other matter that the disputing Party
19 considers might significantly affect the operation of this Agreement, indicate the provisions of
20 this Agreement that are considered relevant, and be delivered by the disputing Party to the
21 other Parties and to its Section of the Secretariat.
22

23 (3) Subject to Article 2313, the terms of reference for the arbitral panel shall be
24

25 (a) to examine, in light of the relevant provisions of this Agreement, the measure or
26 other matter referred to the Commission as set out in the request; and
27

28 (b) to make such findings, determinations, and disposition as provided in Article
29 2317(2).
30

31 (4) Except as modified by this paragraph, the provisions of Chapter 23 apply to an
32 arbitration proceeding that is initiated under this paragraph.
33

34 (5) An arbitration proceeding is initiated under this paragraph on the date of
35 delivery of the request to the Commission.
36

37 (6) An arbitral tribunal established pursuant to paragraph 4 shall cease, on the date
38 on which an arbitration proceeding is initiated under this paragraph, to have jurisdiction with
39 respect to any matter at issue in the proceeding before it that is also at issue in the proceeding
40 before the arbitral panel established pursuant to this paragraph pending determination of the
41 matter by the panel established pursuant to this paragraph.
42

43 (7) The determination and disposition of the arbitral panel, or a settlement by the
44 Parties with respect to any measure or other matter at issue in the proceeding before the panel,
45 is binding on any arbitral tribunal established pursuant to paragraph 4 to which the same matter
46 is or has been referred for arbitration.

48 9. (1) A disputing Party may request the Secretary of the International Chamber of
49 Commerce to establish an arbitral panel.

51 (2) An arbitral panel shall consist of three arbitrators appointed by the Secretary.

2 (3) The disputing Party shall give notice of its request to establish an arbitral panel
3 to all known claimants and to the Party or Parties of the claimants.

5 (4) The disputing Party shall refer to the arbitral panel such issues as it considers
6 appropriate and the panel shall determine and dispose of those issues.

8 (5) The disputing Party, the claimants and the Party or Parties of the claimants shall
9 have the right to be parties to the proceeding before the arbitral panel.

11 (6) No arbitral tribunal or panel established pursuant to paragraph 4, 8 or 10 shall
12 have jurisdiction to decide any issue that is also at issue before an arbitral panel established
13 pursuant to this paragraph pending decision by the panel established pursuant to this
14 paragraph.

16 (7) The determination and disposition of the arbitral panel, or the settlement by the
17 Parties on the issue or issues before it, is binding on the parties to the proceeding before the
18 panel and on any arbitral panel or tribunal established pursuant to paragraph 4, 8 or 10 to
19 which the same issue or issues is or have been referred for arbitration.

20 (8) Except as modified by this paragraph, the provisions of the UNCITRAL
21 Arbitration Rules apply mutandis mutatis to an arbitration proceeding that is initiated under
22 this paragraph.

24 10. Notwithstanding paragraphs 3 to 9, the disputing parties may agree to submit the
25 investment dispute to arbitration in accordance with other arbitration rules or before any other
26 arbitration institution.
27

28 10a. An arbitral tribunal or panel established pursuant to paragraph 4, 9 or 10
29

30 (b) may not order provisional measures; and
31

32 (c) may award only monetary compensation or restitution of property.
33

34 11. General
35

36 Unless the disputing parties agree otherwise, an arbitration proceeding under paragraph
37 4, 9 or 10 shall be held in the territory of any Party to this Agreement that is a Party to
38 the New York Convention, such place to be selected in accordance with the applicable
39 arbitration rules.
40

41 12. (1) An arbitral tribunal or panel established pursuant to paragraph 4, 9 or 10 shall
42 decide the issue or issues in the proceeding before it in accordance with the provisions of this
43 Agreement and applicable rules of international law.
44

45 (2) Subject to subparagraphs 8(7) and 9(7), the decision of an arbitral tribunal or
46 panel established pursuant to this Article shall have no binding force except between the parties
47 to the proceeding and in respect of the particular case.
48

49 13. (1) The award granted by an arbitral tribunal or panel established pursuant to this
50 Article shall be subject to judicial review under the law of the place where the arbitration

1 proceeding is held [or, in the alternative, review by an extraordinary panel under this
2 Agreement].

4 (2) No arbitral tribunal or panel established pursuant to this Article shall order a
5 Party to pay punitive or aggravated damages or to return property that is not owned and
6 controlled by that Party.

8 (3) Where an arbitral tribunal or panel established pursuant to paragraph 4, 9 or 10
9 orders a Party to return property, it shall also order that the Party may pay compensation in
10 lieu thereof.
11

12 (4) Costs in any arbitration proceeding under this Article and interest on any award
13 shall be governed by arbitral law of the place where the proceeding is held.
14

15 14. (1) In any arbitration proceeding under paragraph 4, 9 or 10, the arbitral tribunal
16

17 (a) may take into account amounts that a competent domestic authority has ordered the
18 investor to pay to the disputing Party and that are counterclaimed by that Party;
19 and

21 (b) shall deduct from an award amounts paid by the defending Party under a contract
22 of indemnity.
23

24 (2) Subject to subparagraph 14(1)(b), in any proceeding under this Article involving
25 an investment dispute, a Party shall not assert, as a defense, counterclaim, right of set off or
26 otherwise, that the investor concerned has received or will receive, pursuant to an insurance or
27 guarantee contract, indemnification or other compensation for all or part of its alleged
28 damages.
29

30 14b. An award made under this Article shall be enforceable under [in accordance with] the
31 New York Convention in a country that is both a Party to the New York Convention and a
32 Party to this Agreement.
33

34 15. Subject to subparagraph 13(1) and the applicable provisions of the New York
35 Convention, the Inter-American Convention and the ICSID Convention,
36

37 (a) any arbitral award granted in an arbitration proceeding under paragraphs 4, 9 or 10
38 is final on the parties to the arbitration proceeding; and
39

40 (b) each Party to this Agreement undertakes to carry out without delay the provisions
41 of any arbitral award granted against it in any arbitration proceeding under
42 paragraph 4, 9 or 10 and to provide for the enforcement of arbitral awards granted
43 in arbitration proceedings under those paragraphs.
44

45 16. For purposes of an arbitration proceeding under paragraph 4, 9 or 10, any company
46 that is legally constituted under the applicable laws and regulations of a Party or a political
47 subdivision thereof but that, immediately before the occurrence of the event or events giving
48 rise to the dispute, was an investment of nationals or companies of another Party, shall be
49 treated as an investor of such other Party, including in accordance with Article 25(2)(b) of the
50 ICSID Convention.
51

1 17. (1) Subject to this Article, each Party hereby consents to the submission of any
2 investment dispute between that Party and any investor of another Party for settlement by
3 arbitration in accordance with paragraph 4.
4

5 (2) The submission of an investment dispute for settlement by arbitration in
6 accordance with paragraph 4, together with the consent given by each Party in subparagraph
7 (1), shall satisfy:
8

9 (a) the requirement of Chapter II of the ICSID Convention (Jurisdiction of the Centre)
10 and the Additional Facility Rules for written consent of the parties;
11

12 (b) the requirement of Article II of the New York Convention for an agreement in
13 writing; and
14

15 (c) the requirement of Article I of the Inter-American Convention for an agreement.
16

17 (3) For purposes of Article I of the New York Convention and Article I of the
18 Inter-American Convention, the submission of any investment dispute for settlement by
19 arbitration in accordance with paragraph 4 shall be considered to arise out of a commercial
20 relationship or transaction.
21

22 (4) For greater certainty, subparagraph (3) shall not affect any claim of immunity
23 made by any Party to this Agreement with respect to the enforcement of any arbitral award.
24

25 18. (1) No Party shall give diplomatic protection, or bring an international claim for
26 money damages or restitution of property, in respect of any investment dispute that an investor
27 of that Party has submitted to arbitration under paragraph 4, 9 or 10, unless the other Party
28 concerned has failed to abide by and comply with the New York Convention in respect of an
29 award granted in the arbitration proceeding.
30

31 (2) For purposes of subparagraph (1), "diplomatic protection" does not include
32 state-to-state dispute settlement pursuant to Chapter 23 or informal diplomatic exchanges for
33 the sole purposes of facilitating settlement of a dispute.
34

35 19. Notwithstanding anything in the Agreement, the provisions of this Article and Chapter
36 23 (Dispute Settlement) shall not apply to any Decision by Canada following a review under
37 the Investment Canada Act, with respect to whether or not to permit an acquisition that is
38 subject to review.]

NATIONAL SECURITY

1. MEX USA[Nothing in this Chapter shall preclude the application by a Party of measures necessary for the maintenance of public order, the fulfillment of its obligations under the United Nations Charter with respect to the maintenance or restoration of international peace or security, or the protection of its own essential security interests.

Note: This provision is self-judging.]

CDA[1. Nothing in this Agreement shall be construed to prevent:

- a) any Party from refusing to furnish or allow access to any information the disclosure of which it determines to be contrary to its essential security interests;
- b) any Party from imposing any measure affecting goods, services, service providers, suppliers or investors of a Party which it determines is directly related and essential to:
 - i) supplying a military establishment of a Party with arms, ammunition or implements of war, or enabling fulfillment of a critical defence contract of a Party;
 - ii) responding to a situation of armed conflict involving the Party taking the measure;
 - iii) implementing international agreements relating to the nonproliferation of nuclear, chemical or biological weapons, other nuclear explosive devices, or chemical or biological agents;
 - iv) responding to direct threats of disruption in the supply of nuclear materials for defence purposes.
- c) any Party from taking action in pursuance of its obligations under the United Nations Charter for the maintenance of international peace and security.

2. The Party relying on paragraphs a) - c) shall ensure that its action or measure is that which least infringes the rights or any reasonable expectations of the other Parties under this Agreement, and is no broader in scope or duration than necessary.

3. Any determination made under paragraph 1(b) shall be published promptly in the official journal of that Party. Any determination made under paragraph 1(a) or action taken under paragraph 1(c) shall, where appropriate, be similarly published.

4. Except in cases of emergency, the Party proposing to impose any measure under paragraph 1(b), or proposing to take action under 1(c) shall consult with the other Parties prior to imposing such measure or taking such action.]

MEX CDA[5. If a Party considers that any action or measure taken by another Party under this Article constitutes a disguised restriction on trade or investment or otherwise nullifies or impairs any benefit reasonably expected under this Agreement, it may request consultations. Such consultations shall be held promptly. The Party whose action or measure

1 is the subject of the consultations shall give full and sympathetic consideration to the view of
2 the complaining Party and shall explain, in as much detail as is consistent with its assessment
3 of its security interests, the reasons for the measure. Where appropriate following such
4 consultations, such Party shall re-consider whether its action or the application of its measure
5 could be altered in any way, in order to minimize the infringement of rights and benefits
6 otherwise secured by this Agreement.]

8 CDA[6. No Party may invoke the provisions of this Article to derogate from the requirement to
9 pay compensation for an expropriation in accordance with Article ____ or to permit the
10 transfer of an investment and returns, in accordance with Article ____.]

1 EXTRA-TERRITORIALITY

2
3 MEX CDA[1. No Party may prescribe new laws or enforce existing laws so as to
4 require investors or service providers to act, in the territory of another Party, in a manner that
5 conflicts with the laws of such other Party.]

1 MONOPOLIES

2
3 CDA[1. Nothing in this Agreement shall prevent a Party from maintaining or designating a
4 monopoly.

5
6 2. Prior to designating a monopoly, and where the designation may affect interests of
7 persons of another Party, a Party shall:

8
9 a) notify the other Parties;

10
11 b) upon request, engage in consultations; and

12
13 c) endeavor to minimize or eliminate any unnecessary nullification or impairment of
14 benefits under this Agreement that might otherwise be caused by the designation.

15
16 3. A Party designating a monopoly shall ensure that the monopoly does not engage in
17 discrimination in its sales in the relevant market against investments of investors of another
18 Party, contrary to this Agreement.

19
20 4. A Party maintaining or designating a monopoly shall ensure that the monopoly in its
21 territory, either directly or through an affiliated company, does not use its monopoly position
22 to engage in anti-competitive practices, whether through cross-subsidization with its operations
23 in its relevant market or otherwise, in areas outside the relevant market.]

1 TECHNOLOGY CONSORTIA

2
3 MEX CDA[1. a) No Party shall maintain or introduce any measure that limits or prevents an
4 investor of another Party from participating in a technology consortium or other group of
5 business enterprises respecting the development of or access to technology (in a manner that
6 would violate Article (on national treatment) or Article (on nullification and impairment).

7
8 b) For greater certainty, the terms and conditions for participation in a technology
9 consortia including financial and technology resources shall be determined by the
10 members of the consortia.]

11
12 2. CDA[Any measure imposed by a Party on a global basis that would be consistent with
13 this Agreement but for paragraph 1 of this Article, including those imposed in accordance with
14 the national security provisions of this Agreement, that limits or prevents such participation,
15 shall not apply to the investors of the other Parties unless the other Parties are specifically
16 named as being included in the measure. Any Party proposing to implement such measure that
17 places a restriction or limitation on the investors of the other Parties shall consult with the
18 other parties prior to its implementation.]

1 COMPETITION POLICY

2
3 CDA[1. The Parties agree to implement such laws and regulations as are necessary and
4 appropriate that result in the transparent regulation, as well as enforcement thereof, of
5 anti-competitive conduct by private persons such as anti-competitive agreements, mergers,
6 monopolies and pricing practices and abuse of dominant position, recognizing that such
7 conduct may frustrate the fulfillment of the object and purpose of this agreement.

8
9 2. The obligations of paragraph 1 shall not be subject to review pursuant to section(s) (the
10 dispute settlement mechanisms).

11
12 3. Each party agrees to notify the others prior to the adoption of any such laws,
13 regulations or policies, or modification thereof and, upon request of any other Party, to hold
14 consultations and to consider the views of the other Party(ies).

15
16 4. The Parties recognize that effective competition law enforcement in the free trade area
17 requires cooperation and coordination among national authorities. For the purpose of
18 implementing such coordination and cooperation, the Parties agree to pursue negotiations on a
19 trilateral basis to create, expand or enhance international agreements and arrangements for
20 mutual legal assistance, notification, consultation and exchange of information relating to the
21 enforcement of competition laws and policies in the free trade area.

22
23 5. In the enforcement of their respective competition laws and policies in those cases
24 involving persons, assets, or practices located, or occurring, in the territory of any of the other
25 Parties, each Party shall, in addition to any obligations incorporated in agreements reached
26 pursuant to section 4 (above), assess, and be prepared to advise the other Parties of the results
27 of its assessment of, the following factors:

- 28
29 a) the relative significance of the anti-competitive activities involved of conduct
30 within the enforcing Party's territory as compared to conduct within the other
31 Party's territory;
32
33 b) the presence or absence of a purpose on the part of those engaged in the
34 anti-competitive activities to affect consumers, suppliers, or competitors within the
35 enforcing Party's territory;
36
37 c) the relative significance of the effects of the enforcement activities on the enforcing
38 Party's interests as compared to the effects on the other Party's interests;
39
40 d) the existence or absence of reasonable expectations that would be furthered or
41 defeated by the enforcement activities;
42
43 e) the degree of conflict or consistency between the enforcement activities and the
44 other Party's law or articulated economic policies; and
45
46 f) the extent to which enforcement activities of such other Party with respect to the
47 same persons, including judgements or undertakings resulting from such activities,
48 may be affected.

49
50 6. The Commission shall establish a Competition Policy Committee to consider and make
51 recommendations (no later than) on:

- 1 a) the impact of competition law and policy on trade within the free trade area;
- 2
- 3 b) the impact of trade law and regulation on competition within the free trade area;
- 4
- 5 c) the potential for reliance on competition laws and policies to discipline
- 6 anti-competitive transborder pricing practices and market segmentation.^{13]}

DEFINITIONS

For purposes of this Chapter:

Business enterprise means a business¹⁴ that has, or in the case of an establishment thereof will have:

- a) a place of business;
- b) an individual or individuals employed or self-employed in connection with the business; and
- c) assets used in carrying on the business, and

CDA[that involves a financial commitment for the purpose of commercial gain.]

Entity¹⁵ means any corporation, trust, partnership, sole proprietorship, joint venture or other association MEX USA[whether or not for profit, and whether privately-owned or governmentally-owned.]

MEX USA[**Entity of a Party** means an entity legally constituted under the laws and regulations of a Party or a political subdivision thereof.]

CDA [**Investment of an investor of a Party** means an investment that is owned or controlled directly or indirectly by an investor of such Party¹⁶.

Investment consists of:

- a) a business enterprise located in the territory of another Party;
- b) equity or debt securities of a corporation constituted under the laws of another Party, or in any interest in an entity of another Party that entitles the owner to share the income or profits or to share in the assets on dissolution.
- c) real estate or other tangible property located in the territory of another Party, including leaseholds, [or intangible property excluding intellectual property, located in the territory of another Party,] that is acquired in the expectation of or used for the purpose of commercial gain;
- d) a loan to a business enterprise located in the territory of another Party made or guaranteed by an affiliate of such business enterprise (but not including a loan by a bank or other financial institution as defined in Chapter (on Financial Services),

whether or not such loan is guaranteed by one of the affiliated business enterprises).¹⁷

- e) interests arising from the commitment of significant capital in the territory of another Party to a project or permanent commercial presence in that territory related to (i) contracts involving the presence of the investor's property in the territory of another Party (such as concession agreements, turnkey or construction contracts) or (ii) contracts where remuneration depends substantially on the production, revenues or profits of a business enterprise.

3. For greater clarity, investment excludes the following kind of interests:

- a) claims to money which arise solely from:

- (i) commercial contracts for the sale of goods or services by a national or entity in the territory of one Party to a business enterprise in the territory of another Party;
- (ii) the extension of credit in connection with a commercial transaction (e.g. trade financing); or
- (iii) any other claims to money

and which do not involve the kinds of interests in paragraph 2.

- b) any loan to a business enterprise other than a loan between affiliated business enterprises described in paragraph 2 d).
- c) bonds, treasury bills, or any other kind of debt, security issued by a Party, including those issued by State, Provincial or local governments of a Party.¹⁸

3 1. **GENERAL EXCLUSION: INCOME TAX AND RELATED MEASURES**

4
5 USA CDA[a] Except as provided for in this Article, nothing in this Agreement shall
6 apply to taxes on income or capital gains or on the taxable capital of corporations,
7 including the Assets Tax established by the Assets Tax Law of Mexico.²⁰

49 Article 401 of this Agreement incorporating by reference rights and obligations of the
50 Parties relating to trade in goods under the General Agreement on Tariffs and Trade,
51 and such other provisions of this Agreement as are necessary to give effect to that

Article, shall apply to taxes other than those referred to in paragraph 1, except that the most favoured nation provisions of the Agreement shall not apply to advantages with respect to taxation accorded by a party pursuant to a tax convention or any other agreement or arrangement between two or more parties, relating wholly or mainly to taxation.]

5. CDA MEX[Where, and only if, it has been determined pursuant to this paragraph by the Parties concerned that a taxation measure of a Party is tantamount to an expropriation or nationalization within the meaning of Article ____ of the Investment Chapter, that Article shall apply to a claim by a Party of an investor of such Party that the measure constitutes an expropriation or nationalization. The issue of whether the measure is tantamount to an expropriation or nationalization shall be referred, exclusively by the Parties concerned, for determination by the competent authorities under the tax convention, if any, between the Parties. If this is no such tax convention or if the competent authorities do not agree to consider the issue or, having agreed to consider it, fail to resolve it within a period of six months after the referral, or such other period as may be agreed upon by the Parties, the issue of whether the measure is tantamount to an expropriation or nationalization shall be determined by the Parties under the appropriate dispute settlement provisions of the Investment Chapter.]²¹

5.1 USA[EXPROPRIATION

A claim by a Party or an investor of such Party that a tax measure of another Party constitutes an expropriation shall be resolved under Article ____ of the Investment Chapter. The issue of whether such tax is discriminatory shall be referred for resolution to the competent authorities under a Tax Convention between the Parties. If the competent authorities do not agree to consider the issue, or having agreed to consider it, fail to resolve it within a reasonable period of time, the issue shall be resolved, together with all other issues of the expropriation, under Article ____ of the Investment Chapter.]

6. WITHHOLDING TAX

Without limiting the application of paragraphs 1, 3.1, 3.2, 4, and 4.1, (not all of these can co-exist) and for greater certainty, notwithstanding Article ____ (Transfers) a party may impose or collect a tax by withholding or other means.
