INDONESIA

(Seamless Pipe Casing and Tubing)

The following communication, dated 22 August 2013, is being circulated at the request of the Delegation of Indonesia.¹

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, the Republic of Indonesia hereby notifies on the imposition of a safeguard measure on the importation of Subject Good, for a period of 4 (four) years by the issuance of Minister of Finance's Decree Number 108/PMK.011/2013 dated 30 July 2013, promulgated in the Berita Negara of the Republic of Indonesia Year 2013 Number 985 on 6 August 2013.

1. General Background

On 25 March 2013 the Republic of Indonesia notified pursuant to Article 12.1 (b) on the findings of investigation in which it was concluded that there is a strong evidence of a causal link between the increased volume of imports of the Subject Good and threat of serious injury or actual serious injury as suffered by the Applicant (G/SG/N/8/IDN/14-G/SG/N/10/IDN/14).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia the imposition of a safeguard measure on the importation of the Subject Good.

2. Subject Good

Seamless pipe casing and tubing made from iron or steel, with diameter width from minimum of 2 3/8 inch to maximum of 14 inch, and with yield strength of equal or more than 75,000 Psi, worked or un-worked pipe-end, under HS code Ex. 7304.29.00.90.

3. Description of the Safeguard Measure

1. With reference to the proposal of the Investigating Authority, and taking into account the need to effectuate the safeguard measure as proposed and the relevant requirements stipulated in the WTO Agreement on Safeguards, the Government of the Republic of Indonesia has decided to impose the following safeguard duty:

Timetable of the Safeguard Duty

Period	Safeguard Duty
6 August 2013 – 5 August 2014	Rp 28,439 per kilogram
6 August 2014 – 5 August 2015	Rp 28,001 per kilogram
6 August 2015 – 5 August 2016	Rp 27,564 per kilogram
6 August 2016 – 5 August 2017	Rp 27,126 per kilogram

2. In accordance to Article 7.4 of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia will undertake a midterm review of such safeguard measure in year of 2015.

3. Below is the list of developing countries excluded from the said safeguard measure, and the Government of the Republic of Indonesia reserves the right to modify this list in light of changing import volumes.
