

**AGREEMENT OF RELATIONSHIP  
DISCUSIÓN AND COOPERATION  
BETWEEN  
UNIVERSIDAD TECNOLÓGICA DE NOGALES  
AND  
AUSTIN COMMUNITY COLLEGE**

By this agreement Universidad Tecnológica de Nogales and Austin Community College join together to promote academic, scientific and education partnership between our institutions.

We pledge our cooperation will be mutual value to both Universidad Tecnológica de Nogales and Austin Community College, to our people and our communities. Further, it is based upon international education principles of mutual benefit that assure equality and reciprocity.

Activities of this agreement shall include but no be limited to:

Faculty Exchange.- It shall be the privilege of each institution to nominate one more of their faculty each year to participate in an exchange for the purpose of or lecture in the other reciprocal basis. The host institution will provide an appointment and library/teaching materials for each faculty exchange. Travel, living arrangements, and others cost will be negotiated on an individual basis

Visiting Faculty.- In addition to an exchange of faculty members of the other institution to visit for me purposes of learning of consulting. Such visits must be approved by the faculty member's home institution, the best institution will have primary responsibility for the cost of the visiting faculty member with the exception of international air travel and salary. International air travel and salary may be negotiated

Student Exchange.- Each institution will look with favor upon the exchange of limited number of student each year. The established admission and acceptance policies of each institution will be followed. The cost and details for each student exchange will be negotiated and administered by the appropriate officers of both institution.

Development of other Relationship.- Whereas both institutions agree to the mutual benefit of humanistic exchange this agreement sets apart the opportunity to continue to work together to build other relationships, such as the exploration of library and academic materials, the exchange of performing groups the exploration of opportunities for tele and satellite communicated meeting conferences or other academic endeavors.

Date of this agreement shall become effective May 26, 2002. It will renew annually on June 1, without change unless either party wishes to modify this agreement. Or unless one institution gives six month advance notice of its intent not to renew.

Appointment of Responsibility Officials.- Each institution will appoint one officer to act on it's behalf in all matters of correspondence, arrangements for exchanges and visits negotiations and agreements, and to receive all inquiries from faculty student and administration.

From Universidad Tecnológica de Nogales this official will be José Antonio Cuevas, Director de Vinculación

For Austin community College this official will be Dr. Frank Schorn, Director Center for International Programs

I set my hand to this agreement of relationship and cooperation and pledge my support to this act of friendship and mutual benefit between our institutions and people.
