## Mexico begins exporting bananas to China

During the departure ceremony of the first shipment of Mexican bananas to China, Víctor Villalobos Arámbula, Secretary of Agriculture and Rural Development underlined that this new market is the result of the producers' preventive phytosanitary work, thus the Mexican government will continue their support to help incorporate an increasing number of farmers, especially small farmers.

He stated that our country is held in high regard internationally due to its work and experience in health and safety issues, which enabled opening a market as demanding as China, thus the Secretariat of Agriculture, through the National Service for Agro-Alimentary Public Health, Safety and Quality (SENASICA) will monitor the exact and timely compliance with regulations to help increase the volume of exports.

The first export shipment consists of 39 tons of bananas. 20 tons of bananas come from a packaging company of Teapa, Tabasco, while another packaging company of Mazatán, Chiapas will ship 19 tons of the fruit.

The Secretary underlined that bananas are the fourth most important food in the world, only behind corn, beans and rice, and are main contributors to the food security of many countries and bring significant economic benefits for food producing areas.

Francisco Javier Trujillo Arriaga, General Director of the SENASICA, stated that all orchards that will start exporting to China are free of pests and certified in good agricultural practices, therefore the Secretariat of Agriculture issued a certificate that is physically attached to the shipments and proves compliance with the conditions agreed upon between both governments.

José Ignacio Peralta Sánchez, governor of Colima, thanked the Secretariat of Agriculture and the SENASICA for the technical assistance provided to the producers in order to meet the demands of international markets, and which provides the people of Colima with competitive advantages and higher incomes for their families.

Adrián Pratas Leal, President of the *Comité Sistema Producto Plátano* organization, highlighted that the opening of this new
market contributes to make reality the mandate of President
Andrés Manuel López Obrador of fair and equitable treatment to
all the country's producers, and in turn, farmers are responsible of
increasing exports without neglecting the domestic market.

On May 13, 2019, the Secretariat of Agriculture and the General Administration of Customs of the People's Republic of China (GACC) signed the phytosanitary requirements protocol to export fresh bananas from Mexico to China.

On December 16, 2019, the GACC published in their website the listing of authorized production sites and establishments to start banana imports from Colima, Chiapas and Tabasco.

The GACC authorized 37 production sites free of the moko disease of banana (22 in Chiapas, 14 in Colima and 1 in Tabasco), with an area of 4,767.28 hectares of banana trees (3,025 in Chiapas, 1,520 in Colima and 222 in Tabasco) and 49 packaging companies (17 in Colima, 4 in Tabasco and 28 in Chiapas).

According to *Sistema Producto Plátano*, our country ranks twelfth in banana production worldwide with 2.7 million tons per

year; 30% of the production goes to 43 markets, with an approximate worth of USD\$270 million.
