STEPS TO BE TAKEN:



In case of irregularities are found in the documentation you present, if they do not meet the requirements established for entering the country or there is any legal impediment, the Federal Immigration Agent assigned to the checkpoint will send you to the Secondary Immigration Check.



You will be called to an interview where you will be asked for exact information concerning your visit to Mexico, and the documents you present will be reviewed.



You must wait for the **respective resolution**.



If the resolution is in your favor, you may enter the country when the procedure is concluded and you have gotten a copy of the resolution.



If you are denied permission to enter the country, the reason for the refusal will be explained to you, and the company or the airline on which you traveled will be responsible for your lodging, meals and return to the country from which you came, or that to which you may be admitted. You have to receive a copy of the resolution.

At this time, you are in the **National Immigration Institute** facilities. There is no reason to worry. **We will explain to you** what **this procedure is about.**

If there is any inconsistency, we must check in detail the documents or information that you presented to the immigration authorities.

During this **Second Immigration Check** you will be interviewed again **and asked for your documents and information,** which will be recorded in
a **written report.**

You must **submit** all the **information and documentation** requested of you to justify your reason for traveling to **Mexico.**

The Secondary Immigration Check may not exceed four hours.



The National Immigration Institute ensures absolute respect for your human rights.

While you are in Secondary Immigration Check, you have the following rights:



To be treated with respect.



To have a translator or interpreter who speaks your language.



To be informed of the possibility of **contacting your Consulate** during these proceedings.



To be treated without discrimination for any reason by the authorities.



To be informed of the resolution of the immigration authorities.





To receive a **copy** of the **respective written statement** stating the resolution of the **Secondary** Immigration Check.



To receive **food and lodging** provided by the **carrier or airline** while a **rejection** is being processed.

The Second Immigration Check is duly contemplated in Articles 6, 14 and 87 of the Immigration Law, and in Article 3, Sections II and XXV, and Articles 57, 60, 62, 65, 78, 79 and 98 of the Immigration Law Regulations in Mexico.
