Migration and Health

Call for papers, Edition 2021

The Ministry of the Interior, through the National Population Council (CONAPO), invites specialists in migration and health issues to participate in the digital publication Migration and Health 2021.

The publication's main purpose is to make available to government, academics, civil associations and the general public, current issues related to the health of the population that migrates in the Mexico-United States and Central America-Mexico corridor.

Short articles (4000-5000 words) will be considered, an External Specialized Editorial Committee will review them throughout a double-blind process (peer-reviewed). During the evaluation, compliance with the established publication guidelines, as well as the quality and relevance of the articles will be reviewed.

Main topics of interest

Priority, but not exclusive, issues for the various population groups —girls, children and adolescents, older adults, youth and / or the economically active population, women—, in any of the phases of migration (origin, transit, destination or return , as well as cross-border migration), are the following:

1. COVID-19 pandemic
2. Sexual and reproductive health
3. Violence from a public health perspective
4. Mental health
5. Health care
6. Chronic diseases
7. Infectious diseases
8. Occupational health
9. Access to health service
10. Households and health

Selection process

- The documents must be original and have not been sent to be published in another book or magazine.
- The documents must comply with the publication standards of the Editorial Committee and use inclusive language, be clearly written and be prepared with the spelling rules of each language..

- Articles must be in the format of citing the American Psychological Association (APA) sixth edition. **See document: Editorial guidelines for the preparation and delivery of articles for the digital publication Migrationa and Health 2021.**
- Articles submitted for consideration can be written in Spanish or English, and meet the requirements indicated in the content and format guides. When the article has more than one author, it must be written in the mother tongue of the main author.
- The initial evaluation of the articles will be in charge of the SGCONAPO. Subsequently, an external Specialized Editorial Committee will conduct a double-blind peer-review.
- The opinion can be of rejection, acceptance or conditional on making the modifications suggested by the external reviewers. In each case, the corresponding notification will be made.
- Rejected articles will be those that do not comply with the editorial policy of the organizers, as well as those that do not have an acceptable quality for publication.
- Articles with observations will have a maximum time of 15 calendar days for their incorporation.
- The reviewers of the articles will be specialists in the matter.
- Articles will be published in the language in which they were sent (English or Spanish, as the case may be)
- The maximum number of authors per article will be three.
- In all cases, the copyright will be transferred to SGCONAPO.

Important dates

- Call for papers publication: April 16, 2021
- Receipt of articles: June 15, 2021
- SGCONAPO will determine whether articles received after June 15 may be included in the next edition.
- Notification of rejection, acceptance and / or comments of the evaluators: July 16 to 18, 2021.
- The publication will be digital and will be subject to the deadlines established by Indautor.
