Content of the manuscript

1. Abstract (100 words)
2. Key words
3. Introduction (max. 400 words) that includes:
 - a. Relevance of the topic for the two countries
 - b. Quantitative support of the article
 - c. Brief description of the sections of the documents
4. Background (max. 500 words)
5. Methodology (max. 500 words)
6. Results, discussion and analysis (max. 2000 words)
7. Conclusion and policy recommendations (max. 1500 words)
8. References (max. 2 pages)
9. Short note of the authors (max. ¼ page)

Quick guide about the manuscript format

1. Article manuscripts should be sent in text processor.
2. Paper size should be legal (8.5 x 14 inches).
3. Font: Times New Roman points, 1.5 spaced.
4. Margins: custom 1".
5. Manuscript extension around 4000 and 5000 words (10 pages) without figures (Max. number of figures in the document are 3).
6. Sections should be not enumerated, however, it could be included subsections
7. Text, including titles and subtitles, should be used uppercases and lowercases (no blocks of caps).
8. Titles and subtitles without punctuation.
9. Acronyms and roman numbers should be written in Versalita.
10. English words, Latin words or words in any foreign language should be written in italics.
11. Tables, illustrations, and figures should be indicated in the body of the text (see Figure 1...).



12. Footnotes should have a font size of 8 points.
13. Separation of thousands should be indicated with space, no comma or apostrophe.
14. Decimal numbers should be separated by a dot and with few exceptions just one decimal number after the dot.
15. “Percent” should be used in the body of the text. If you are referring to a number in a parenthesis, you should use %.
16. Percent should be indicated as a % in the footnotes.
17. Digits throughout 0-9, and cyphers ten, eleven, and twelve should be written down. Use always numbers if you are using decimals or are using hundreds or thousands.
18. United States abbreviation in Spanish should be EE. UU., and in English U.S.
19. Inclusive and nondiscriminatory language should be used in the manuscript.

Style guide for the manuscript format

1. Title of the tables and figures should not include final punctuation.
2. Enumeration of tables and figures should be done in a consecutive order.
3. “Percent” should be used in the font and sources of the tables and figures.
4. Cyphers should be separated by a space no commas or apostrophes.
5. Decimal numbers separated by a dot and with few exceptions just one decimal number.
6. Figures should not have any 3D effect.
7. Tables, illustrations, and figures should be sent in a separated editable file.

Quotations and references in the text should meet the criteria American Psychological Association (APA) Sixth edition. See,

Additional elements for the authors:

- Footnotes should be enumerated in a consecutive order, and they should be used the least as possible.
- Quotations of 40 or more words should be set in a blocked quotation without quotations marks.
- Figures and tables should be enumerated in a consecutive order.
- Authors are responsible of the adequate use of the copyrights of the materials include in their manuscript:

Quotation example:

"Tras el retroceso de las remesas en 2015 y 2016" (CONAPO, 2018, p. 116), o según CONAPO (2018) "Tras el retroceso de las remesas en 2015 y 2016" (p.116).

Blocked quotation should be indented. Example, CONAPO (2016) has reported that,

En las últimas décadas, la movilidad de personas tanto a nivel nacional como internacional ha abierto nuevas dimensiones en el análisis del fenómeno migratorio que no se ubican en la concepción tradicional de la migración entendida como cambio de residencia. En este sentido, el dinamismo de los movimientos humanos ha planteado la necesidad de hablar de la movilidad de la población como el gran abanico que incluye no sólo la migración, sino los desplazamientos de corta o larga duración que no implican ningún cambio de residencia (p.7).

In conclusion and paraphrasing should not have the page number.

Example, CONAPO (2018) has reported that the cost of transit through Mexico to reach the United States increased in the last years.
