## **Request the Animal Health Export Certificate for pets**

It is free of charge and is valid for 8 calendar days (it may vary in case the destination country establishes a different validity period).

Once you have consulted the <u>Requirements Module</u>, (where certification legends for the country you intend to travel to are available), check the vaccines or treatments you will have to administer to your pet, as well as their period of application, or any other provision.

Now request the Zoosanitary Certificate for Export (CZE, by its Spanish acronym) (Senasica-05-001-B) in any of our <u>authorized offices</u> nationwide, with the following documents:

**1.** Application <u>Format</u>: Application to obtain the certificate for export of regulated merchandise in agricultural, livestock, aquaculture and fishery matters.

**2.** Official Identification of the owner of the animal that will travel.

**3.** When it is not the owner who is processing the certificate, a simple power of attorney signed by the interested parties and 2 witnesses must be presented (accompanied by photocopies of current official identification of those involved, in accordance with Article 19 of the Federal Law of Administrative Procedure).

**4.** Health certificate of the animal that will travel, issued by a private veterinarian, no more than five days old or according to the validity established by the country of destination, with the following information:

- Pet data: Name, microchip number (when applicable) breed, coat color (do not indicate own breed), sex and age.

- Name of the owner and address in Mexico.

- The veterinarian's examination must report that the pet does not present fresh or healing wounds, nor any sign of infectious or contagious disease.

- Any other specific requirement requested by the country of destination (check the <u>Requirements Module</u>).

**5.** Vaccination card or document indicating that your pet has been vaccinated against rabies (from three months of age) and, if applicable, other vaccinations required by the country of destination, including the following information:

- Name of the vaccine, laboratory, lot number, expiration date, date of application and validity period, if no specific validity is included, it will be considered one year.

**6.** When applicable, a booklet or document that accredits the deworming that was applied to your pet according to what is requested by the country where they will travel, including: Name of the deworming agent, laboratory, dosage, expiration date and date of application.

**7.** In case it is requested by the country where they will travel, a document indicating the microchip number, date of application or reading as well as the owner's data.

**8.** Results of official or approved or authorized laboratory tests, when requested by the country to which they will travel.

## Period of response of the procedure

It will be delivered to you within three working days after the working day of the date of delivery of your application with the documentation proving the requirements established by the country of destination.



- It is important that you take the necessary time to comply with these requirements, so that you do not have any setback on the day of your trip, since if the documentation is not complete or correct, the response may be a document requesting the completion or correction of the information or a refusal.
- The day you go to the offices to carry out your procedure, you must know the complete address in Mexico and in the country of destination.
- When you fulfill the requirements established by the country of destination and at national level, the CZE will be elaborated and a first seal and signature will be granted, it is not necessary to present your pet.
- On the day of your trip you must take your pet to the Senasica office at the point of departure, where the official personnel will perform a physical examination and if everything is in order, the second stamp and signature will be given to your CZE.
