



Appendix 01 List of allowed and prohibited agro-alimentary products and byproducts for tourism import.

VEGETABLES AND AUTHORIZED PRODUCTS AND BYPRODUCTS FOR TOURISM IMPORTS.

Allowed products

The products authorized for introduction, through visual inspection only, are listed in section e) of Appendix 1 of the AGREEMENT that establishes the imported goods subject to regulation from the Secretariat of Agriculture and Rural Development, and the issuance of the certificate of origin for coffee exports, through the National Service for Agro-Alimentary Public Health, Safety and Quality (DOF, 26/12/2020/ and its amendments on 16/06/2021). Such products must be free of pests and in amounts fit for personal use and consumption. These include:

- · Peeled almonds
- Peeled hazelnuts
- Roasted coffee
- Pelletize cereals
- Spices (vanilla, cinnamon, clove, nutmeg, mace, melegueta pepper, cardamom, anise, coriander, fennel, ginger, saffron, turmeric, thyme, bay leaves, curry, etc.)
- Dehydrated fruits (seedless)
- Cereal, oilseed and legume flours
- Medicinal herbs (dried only)
- Dehydrated vegetables
- Ikin palm tree seeds (maximum 40 seeds for personal use-information note 76/2014:
- Shelled cashews, cashew nuts
- Dried pistachios (salted)
- Dehydrated tobacco. Compliance with the Secretariat regulations does not exclude compliance with other authorities
- Dried yerba mate

Prohibited products

*Dirt or soil

*Pots or articles with vegetable or unknown contents.

The introduction by tourists of the products listed below is prohibited if the importer fails to meet the requirements set forth in the following link. https://sistemasssl.senasica.gob.mx/mcrfi/

- Flowers, plants, in vitro plantlets, fresh vegetables and fruits
- Grains (corn, black bean, rice, quinoa, wheat, sesame, sunflower, cowpea,
- lentil, etc.). Coffee and green tobacco
- Fresh chestnuts.

NOTE: This list is not exhaustive.

The goods inspected in their entirety must be free of pests. If holes bored by insects or live pests are detected, the entirety of the seeds and/or goods will be returned or destroyed.

Likewise, any containers with dirt, foliage, seeds, grains, and any other vegetable traces or residues will be returned or destroyed, as per Official Letter B00.01.01.02.03 25-Sep-14 and phytosanitary measures, etc.





ANIMAL SOURCED PRODUCTS AND BYPRODUCTS FOR HUMAN CONSUMPTION

Allowed products

The products authorized for introduction, through visual inspection only, are listed in c) of Appendix 1 of the AGREEMENT that establishes the goods regulated by the SADER, and the products listed in section b) of said AGREEMENT must demonstrate compliance with requirements established by the zoosanitary unit, at the port of entry to the country (except toe products listed herein).

Considerations for the introduction of the following products:

- The packaging must be intact, and labeled in Spanish, English, or any other intelligible language (Italian, Portuguese, French, etc.), and sealed by the health authority.
- ✓ They must originate from countries with a combination of zoosanitary requirements in the MCRZI: https://sistemasssl.senasica.gob.mx/mcrz/moduloConsulta.jsf.
- As per the indications in the Zoosanitary Requirements Sheet (HRZ) applicable to the introduction of goods, all products must originate at a plant authorized by the Secretariat, in accordance with the stipulations of the Information System for Authorized Plants, available at https://sistemasssl.senasica.gob.mx/PlantaAcreditada/the goods must match the process authorized for the plant.

Prohibited products

- ✓ Fresh meat from any species.
- ✓ Balanced feed for any species (except for cats and dogs.)
- ✓ Balanced food for cats and dogs <u>with beef, lamb and goat meat</u>. (This will apply only if the country of origin does not have a zoosanitary requirements sheet published in the MCRZI Import Requirements Consultation Module.
- ✓ Sandwiches, snacks, sub and Cuban sandwiches, hamburgers, pizzas, etc. with meat and dairy contents without an intact packaging or a sanitary seal from the competent authority.
- ✓ Pharmaceutical, chemical, and biological products for animal use or consumption, or products indicated for therapeutic or research purposes.
- ✓ Fresh cheeses.
- ✓ Homemade or artisanal products are not allowed.
- ✓ Campero-type (fried) chicken.
- ✓ Untanned leather products.
- ✓ Pots or articles with animal, vegetable or unknown contents.
- ✓ Game trophies (mounted, fresh, salted, etc.)
- ✓ Any regulated animal species (except cats and dogs.)
- ✓ Containers carrying animals, or animal remains (blood, feathers, bones, waste, others.)
- ✓ Bullfighting, Mexican horsemanship (charrería) and bull riding garments and paraphernalia, when stained with animal blood or tissues. Their introduction is allowed if they are completely cleaned, disinfected and undergo sanitary treatment at the point of entry.
- ✓ Garments with animal bones, skin, and feathers, horn, or carved or polished bone craftwork, if stained with blood or any other materials propagative of diseases or pests. Their introduction is allowed when the presence of the aforementioned materials is discarded, and the product's characteristics are established as a non-sanitary risk.
- ✓ Pork products and their byproducts sourced from countries affected by the African swine flu: ham, sausages, bacon, cracklings, candy with pork meat, raw pork meat, dry meat, smoked chops, precooked cold cuts, pasta with pork meat, BBQ ribs, pork lard, instantaneous soups with pork content, bacon toothpaste, salami, mortadella, ham sandwich, chorizo, etc.

AQUACULTURE PRODUCTS

Allowed products

Introduction of all fishes of any species for animal consumption is allowed if they are duly packaged and labeled, in accordance with section d) of Appendix 1 of the AGREEMENT that establishes the goods regulated by the SADER.

Prohibited products

Live, raw, and dry crustaceans.

Aquaculture products (except fillets and fish for animal consumption)

Fish.

Live turtles.

Regulated aquatic products in bad condition, rotting, or containing larvae or insects.
