Plant origin vegetal

- Earth or soil
- Vessels or articles of unknown or vegetable origin.
- The entry of the products listed below is prohibited for tourism, if the importer does not comply with the requirements described in the following link. <https://sistemasssl.senasica.gob.mx/mcrfi/>
- Propagative material (seeds, bulbs, cuttings, buds, cuttings, etc.)
- Flowers, plants, in vitro seedlings, fresh vegetables and fruits.
- Grains (corn, beans, rice, quinoa, wheat, sesame, sunflower, beans, lentils, etc.).
- Coffee and green tobacco
- Fresh chestnuts



Animal origin

- Balanced feed for any species (except for dogs and cats).
- Balanced dog and cat food with beef, sheep and goat meat. (As long as your country of origin does not have an animal health requirements sheet published in the MCRZI import requirements consultation module).
- Fresh meat of any species.
- Containers with animals, animal remains (blood, feathers, bones, offal, other).
- Any regulated animal species (except dogs and cats).
- Clothing with bones, skin and feathers of animals, carved or polished horn or bone handicrafts, when presented with blood or any other material propagating diseases or pests. Entry is allowed when the presence of the aforementioned materials is ruled out and it is verified that it is a product whose characteristics do not represent a sanitary risk.

- Clothing and accessories for bullfighters, charrería and bull riding, when they present blood or remains of animal tissues; their entrance is allowed when they are presented completely clean and disinfected and prior prophylactic treatment at the point of entrance.
- Homemade or handmade products are not allowed.
- Free-range chicken.
- Products of pork origin and its derivatives, originating from countries with African Swine Fever, such as: ham, sausages, bacon, bacon, pork crackling, sweets with pork meat, raw pork meat, dried meat, smoked chops, pre-cooked sausages, pasta with pork meat, BBQ ribs, pork flour, pork lard, instant soup with pork, bacon toothpaste, salami, mortadella, sandwich with ham, chorizo, etc.

- Rawhide products
- Pharmaceutical, chemical and biological products for animal use or consumption, nor those indicated for therapeutic or research purposes.
- Fresh cheeses.
- Sandwiches, snacks, cakes, sandwiches, hamburgers, pizzas, etc., with meat and dairy content without full packaging or sanitary seal of the competent authority.
- Hunting trophies (mounted, fresh, salted, others).
- Vessels or articles with contents of animal, vegetable or unknown origin.



Aquaculture origin

- Live, raw and dried crustaceans.
- Aquaculture products (except fillets and fishes for animal consumption).
- Fish
- Live turtles
- Products of regulated aquatic origin, in poor condition, decomposed or with presence of larvae or insects.
