



## Migration and Health

### Call for Papers, Edition 2024

The Ministry of the Interior, through the National Population Council (CONAPO), invites specialists in migration and health issues to participate in the 2024 edition for the digital publication “Migration and Health” with Reservation of rights [04-2019-101614350400-203] and ISSN [2683-2488] both granted by INDAUTOR.

The purpose of this publication is to compile unpublished studies or studies in the process of completion on the issues of health and international migration in the Mexico-United States-Canada and Central America-Mexico-United States-Canada corridor. Its final objective is to serve as a primary input to guide decision-making, the development of strategies, and the implementation of actions within the Federal Public Administration, the different levels of government, and as an essential reference for specialists, civil society organizations, and people interested in the subject.

It is suggested that the papers be of short length (4000-5000 words) will be considered. These will be reviewed internally to ensure compliance with SGCONAPO 2023 editorial guidelines for publication, as well as the quality and relevance of each article, and by an external specialist.

### Main topics of interest

The papers should address populations in international mobility in any of the phases of migration (origin, transit, destination, return, repatriation), refugee and forced displacement, and any other type of mobility such as tourism. It is desirable that the articles be developed with a gender, generational or intersectional approach.

1. Public health policy challenges for the migrant population
2. Health care and health problems in the context of collective and/or mass migration
3. Health, disease, and mortality in transit contexts
4. Population with prolonged or long-term stays
5. Migration and gender violence as a public health problem
6. Sexual and reproductive health
7. Access and health care coverage and care
8. Mental health, chronic and infectious diseases
9. Occupational health
10. Residential arrangements and healthcare
11. Migration and addictions



## Selection process

- Papers submitted must be original.
- Papers submitted must comply with the editorial guidelines that accompany this call.
- Papers submitted for consideration can be written in Spanish or English, and meet the requirements indicated in the content and format guides. When the article has more than one author, it must be written in the mother tongue of the main author.
- The initial evaluation of the papers will be the responsibility of the General Secretariat of the National Population Council (compliance with editorial guidelines and first review of content); subsequently, external specialists will carry out a review.
- The opinion can be of rejection, acceptance or conditional on making the modifications suggested by the external reviewers. In each case, the corresponding notification will be made.
- Rejected papers will be those that do not have an acceptable quality for publication due to internal and the external review.
- Articles with observations will have a maximum time of 15 calendar days for their incorporation.
- If the institutional conditions exist, the papers may be translated into English or Spanish, or they will only be published in the original language in which they were submitted.
- In all cases, copyrights will be transferred as indicated in the copyright section of the SGCONAPO 2023 editorial guidelines in accordance with this call.

## Important dates

- CFP publication: January 10, 2024
- Reception of articles: from February 10 to May 10, 2024
- CONAPO will determine whether articles received after the deadline may be included in the next edition.
- Notification of rejection, acceptance and/or comments of the National Population Council: 15 natural days after initial receipt.
- Notification of rejection, acceptance and/or comments of the external evaluation: 15 natural days after the CONAPO's' notification of sending to an external opinion.
- Final notification of acceptance or rejection: May 24.
- The publication will be digital and will be subject to the deadlines established by Indautor.
