

## Frequent Traveler Pet Program

It is very useful if you enter Mexico with your pet at least three times a year

It is designed for users, Mexicans or foreigners, who regularly enter Mexico accompanied by their pets, regardless of their country of origin \*

### **Not applicable for domestic and export flights**

*\*For USA and Canada, it is not necessary to register, since it is not required to present documents to process the Zoosanitary Certificate for Importation (which is issued for the entry of dogs and cats into national territory)*



### Advantages

- Free of charge
- Expedite your entry to Mexico
- It is valid for one year
- You will not have to present a health certificate every time your pet enters the country

### **. PMVF registration is done online through the Tourism Certification**

### **System (CERTUR, by its Spanish acronym)**



For the registration of your pet, you must digitalize:

- Certificate of good health on letterhead and with the license number of the Veterinarian who issued it (it will be valid for 6 months, and it will not be necessary to process it for each entry into Mexican territory, until it has expired)
- Current rabies vaccination (valid for 1 or 3 years, depending on the veterinarian's specifications)
- Internal and external deworming (valid for 6 months)

- Recent picture of your pet (JPG)
- Copy of the professional license or equivalent of the Veterinarian who issued the Certificate of Good Health

*Afterwards, you will be able to enter your pet's general data and attach the documentation in PDF format, the files should not exceed 5 megabytes.*

Renewal

- Present a new certificate of good health (must be no more than 15 calendar days old)
- Proof of current internal and external deworming \*
- Current rabies vaccination\* (only in case the one presented for registration in the PMVF is no longer valid)

*\* In the case of rabies vaccination and deworming, these may be described in the health certificate or vaccination booklet*



User registration, national or foreign

Enter the Tourism Certification System (CERTUR), in which you must enter the following data:

- Name
- Date of Birth
- Applicant's Official Identification
- CURP (Not required for foreign users)
- Country (foreigners only)
- State
- Address
- Contact information (phone number and email)
- In the second owner section you can register another person to accompany your pet

*Once you have entered the data and attached the documents, you must select "send the application" for registration*



## Registration Considerations

- If you meet all the requirements, your application will be approved and you must present your pet at the Agricultural Health Inspection Office (OISA, by its Spanish acronym) that you indicated in your application, for a brief physical inspection along with the documentation you uploaded (original and copy)
- If all is well, you will be given the PMVF with which you can enter the country with your pet
- If your application has any requirements, you will have an opportunity to resolve them
- If your application is rejected, you must generate a new application



## Upon arrival in Mexico

You must contact Senasica personnel located at OISA at your point of entry into the country to perform a physical inspection of your pet and you must present your PMVF
